### H.E. OKNHA DATUK OTHSMAN HASSAN

Minister Attached to the Prime Minister & Secretary of State, Ministry of Labor and Vocational Training, Cambodia

With just a high school level education during the pre-Pol Pot period, H.E. Oknha Datuk Othsman Hassan, a Cambodian businessman, started as a normal worker at a rubber plantation, and rose to become head of numerous companies such as a nail and steel factory, Cambodia Travel and Tours, Hassan Import Export Co., Ltd., Global Impex Motor Cambodia Co., Ltd., Human Resource Development Co., Ltd., Security Printing Co., Ltd., CAMGAS Co., Ltd., Princess Angkor Hotel, and many more.

As a successful businessman, H.E. Oknha Datuk Othsman Hassan was given a tycoon title called "Oknha" from the Cambodian King, H.M. Norodom Sihanouk in 1998 and from the Malaysian Government called "Datuk" in 2012.

H.E. Oknha Datuk Othsman Hassan currently serves as President of the Cambodian Muslim Development Foundation (CMDF); the first largest Muslim local organisation branched in all districts-provinces of Cambodia. He is also the Chairman of the Implementation Committee of the Islamic Development Bank Scholarship Program for Cambodia and Chairperson of the Islamic World and Malay to Cambodia (SDMDI), Patron of the Islamic Medical Association of Cambodia and a member of the Board of Directors of the Cambodian Islamic Centre (CIC).

With the confidence from the Royal Government of Cambodia, H.E. Oknha Datuk Othsman Hassan served as Minister attached to the Prime Minister: Secretary of State of Ministry of Labor and Vocational Training since 1998. He has been appointed as an Advisor and Special Envoy for Islamic affairs to the Cambodian People Party (CPP) and Samdech Akka Moha Sena Padei Techo HUN SEN, the Prime Minister of the Kingdom of Cambodia.



## THE. HON TUN MUSA HITAM Chairman, WIEF Foundation & Former Deputy Prime Minister of Malaysia

Tun Musa Hitam, who is currently Chairman of the World Islamic Economic Forum (WIEF) Foundation was Malaysia's Deputy Prime Minister until 1986. In the course of his service in the Malaysian government, he held various positions including Minister of Home Affairs, Education, Primary Industries and Trade and Industries and Chairman of the Federal Land Development Authority (FELDA). Among his major official activities were as Leader of Malaysian Investment Missions to Europe, USA and Japan and representing Malaysia at UN ECOSOC related negotiating and regular conferences.

Since Tun Musa's retirement from politics in 1987, he held Chairmanships of 3 Public Listed Companies and various business related institutions both at domestic and international levels. He was Chairman of the Malaysia – China Business Council, Co-Chair of the Eminent Persons Group (EPG) of the Asean – China, 15 year economic cooperation program and Chairman of the EPG to draft the Asean Charter. Currently, Tun Musa is Chairman of the Sime Darby Foundation, Chairman of the International Advisory Panel of CIMB Bank, Chairman of the International Selection Panel of the Royal Award on Islamic Finance and member of the Advisory Panel of the Iskandar Development Authority.

Tun Musa holds a BA (University of Malaya) and MA (University of Sussex) and held a resident Fellowship at Harvard University. For his services to the nation, The Yang Di Pertuan Agong (King) of Malaysia conferred him Malaysia's highest award which carries the title "Tun".



## PROF. DATUK DR SYED OTHMAN ALHABSHI Deputy President Academic, International Centre for Education in Islamic Finance (INCEIF), Malaysia

Prof. Datuk Dr Syed Othman Alhabshi is the Deputy President Academic of INCEIF. He joined INCEIF as Professor of Islamic Economics & Econometrics and Head of Takaful Faculty in March 2007.

He holds a B.Ec (Hons) in Statistics from University of Malaya, M.S. (Statistics) from University of Wisconsin, USA and Ph.D. in Econometrics from University of Birmingham, UK. Since 1969, he has served in various academic capacities in four public universities in Malaysia, namely University of Malaya, Universiti Kebangsaan Malaysia, International Islamic University Malaysia and Universiti Utara Malaysia. In October of 1997, he served as the Founding President and CEO of Universiti Tun Abdul Razak until March 2005, after serving Institute of Islamic Understanding Malaysia (IKIM) as the Deputy Director-General from 1992 to 1997.

He was a member of Etiga Takaful Berhad Board (1995-2013), Maybank Islamic Board (2006-2014), Asia Unit Trust Board (1994-2012), among others. He is currently a member of the Board of Directors of Prima Prai Sdn Bhd; Epen Bina Sdn Bhd, Universiti Teknikal MARA Sdn Bhd and Institut Kefahaman Islam Malaysia (IKIM). He is also a member of Dubai Center for Islamic Banking & Finance Advisory Board, Malaysian Insurance Professional Standards Council (MIPSC) and IFSB Working Group - Guiding Principles for Retakaful (Islamic Reinsurance) Undertakings. He now sits on Shariah Advisory Committee for Labuan Reinsurance (L) Ltd.; Amanah Mutual Berhad (formerly known as Maybank Unit Trust Berhad), Singapore Unit Trusts Ltd. (SUT) and Prudential BSN Takaful Berhad. He is also a Shariah Advisor for Nomura Asset Management Malaysia Sdn Bhd and a Certified Shariah Individual by the Securities Commission of Malaysia. He has written and publish numerous articles on various topics related to Islam, Economics, Banking, Takaful, Ethics and has written and edited a total of 12 books.



## **KUNRAT WIRASUBRATA** Acting Director, Islamic Development Bank (IDB) Group Regional Office, Kuala Lumpur, Malaysia

Kunrat Wirasubrata is the Acting Director of IDB Group Regional Office, Kuala Lumpur. He has been in development banking (World Bank and IDB) for more than 20 years, and before his posting in Kuala Lumpur, he was IDB's Regional Manager for East and Central Africa, and Country Manager for a number of Central and South Asian countries.



## TAREK M. GENENA Consultant, VTrust Appraisal, Cambodia

Tarek M. Genena is a capital markets professional specialising in Mergers, Acquisitions, LBOs, Restructurings and Recapitalisations. He has over 25 years of experience in Investment Banking and Corporate Finance as well as handson operating management experience in various industries including defense, aerospace, distribution, manufacturing and finance.

Early in his career Mr Genena worked extensively with top tier NYC, LA and Chicago Law and Accounting Firms and was involved in multiple acquisitions from NYSE companies. He has lived in the Middle East at several points in his life and is fluent in Arabic. He obtained his Bachelor's degree from Drake University from Des Moines, Iowa in Chinese history.

He currently lives in Phnom Penh, Cambodia, where he is actively involved in assisting the development of companies wishing to list on the Cambodian Stock Exchange. ## **MUHD. RAMADHAN** FITRI BIN ELLIAS Executive Vice President & Head of Shariah Management, Maybank Islamic Berhad, Malaysia

He is currently the Executive Vice President and the Head of Shariah Management at Maybank Islamic Berhad. As the Head of Shariah Management, Mr Ramadhan oversees all Shariah related matters pertaining to retail, business and corporate banking, treasury, debt market, equity markets and asset management.

Prior to Maybank Islamic, Mr Ramadhan served as Senior Manager at Islamic Markets, Maybank Investment Bank. He also formerly served as a Manager in the Shariah Advisory at RHB Islamic Shariah. He started his career as an Assistant Lecturer of Islamic Economy at University of Malaya.

He has presented several papers at local and international conferences and he is a regular contributor to the Islamic banking column in a few local newspapers.

Mr Ramadhan holds a Bachelors in Shariah (Figh and Usul) (1st Class Honours) from the University of Malaya and a Masters of Figh and Usul Figh from the International Islamic University of Malaysia.



#### **SOUM SAMBATH**

Secretary General, Federation of Associations for Small and Medium Enterprises of Cambodia (FASMEC) and Chief Executive Officer, Cambodian Chemical Supply Co., Ltd., Cambodia

Soum Sambath, 43, is the Chief Executive Officer of Cambodian Chemical Supply Co., Ltd. (Cam-Paint). He was an orphan since he was six years old and used to live in a refugee camp near the Thai border. He did not have the opportunity to graduate with any degree and only finished primary school.

Soum Sambath has worked for two organisations, UNPRO and UNTAC, before his career with other private, local and multinational companies. Through talent and perseverance, he became successful in his career, starting from a salesman to top management within a duration of ten years. In 2004, he started his own business called Cam-Paint, which is now the biggest local paint manufacturer in Cambodia.

Soum Sambath has never stopped developing his knowledge. Despite finishing only level six, he has read over one thousand books from different fields, and has participated in hundreds of short-course trainings both within the country and abroad.

With his commitment in developing general knowledge, Soum Sambath has become highly successful in business and has gained social recognition. He has been invited to be a guest speaker and was interviewed in many programmes on TV, newspapers, magazines, conferences and workshops on business, entrepreneurship, and leadership. He was also appointed to be Secretary General of Federation of Associations for Small and Medium Enterprises of Cambodia (FASMEC).



## DATO' HAFSAH HASHIM Chief Executive Officer, SME Corp. Malaysia

Dato' Hafsah Hashim has held the position of Chief Executive Officer since March 2005. As the Chief Executive Officer of SME Corporation Malaysia, she is responsible in coordinating and overseeing policies for the overall development of SMEs in the country.

Having served under the Ministry of International Trade and Industry, Ministry of Agriculture, and Ministry of Primary Industries, Dato' Hafsah has acquired many years of experience and knowledge that has allowed her to be entrusted to hold top positions in the civil service.

She is also a Board Member, Council Member, Advisory Panel and member of various esteemed and well-known organisations, corporations, councils, and committees. Recently she has been appointed as a Senior Vice President (Development) for the International Council of Small Business (ICSB).



**SALIH TUNA ŞAHIN** Vice President, Small and Medium Enterprises Development Organisation (KOSGEB), Turkey

Şahin has served in the Small and Medium Enterprises Development Organisation (KOSGEB) as the Vice President since 2007.

He studied metallurgical and materials engineering in Middle East Technical University between 1990-1995 and started his career in Turkish Standards Institution.

He became the Ministerial Advisor of the Ministry of Industry and Trade in 1999. He moved to KOSGEB in 2000 as a Vice President. He was appointed to the Turkish Standards Institution (TSI) as the Head of the Supervisory Board. He was assigned as Acting President of KOSGEB in 2002. He became the Adviser to the President between 2003-2007. He has been assigned as the Head of Personnel Certification Commission of the TSI since 2005 and the Head of Neutrality Commission of the TSI since 2007. He was the Deputy Chairman of Board of Directors of the Credit Quarantee Fund between 2007 and 2015.

He is a Member of the Executive Comittee of the Turkish Research & Business Organizations Public & Private Partnership (TURBO) since 2008 and was a Member of the Board of Directors of the Istanbul Venture Capital Initiative (IVCI) between 2008-2013. He has been appointed the Vice President of the IVCI since June 2013.



## **MAO SAVIN** Co-Founder, Cambodia Investor Club (CIC) and Founding Member, Emerging Markets Investments (EMI), Cambodia

Savin has been instrumental in developing venture capital and private equity investments in Cambodia and Laos. He is a founding member of Emerging Markets Investments (EMI), the first SME-focused fund manager in Cambodia, Laos and Myanmar with primary targeted investments in sectors such as education, food and beverage, financial sector, agro-processing, and technology.

In addition to EMI, Savin is also a Co-Founder of the Cambodia Investor Club (CIC) and Chair of its Investment Committee. CIC is a platform to support entrepreneurs both well-established and startup entrepreneurs through providing financing solutions, seed/early stage capital investments, and learning opportunities through members' forum both formal and informal as well as business coaching services among the members. As of today, CIC has 200 members of which 60% are entrepreneurs and the remaining are high-level professionals.

Savin is also a keen social entrepreneur. In 2001, he co-founded Cambodian Rural Development Team, a local NGO working to improve livelihood of rural communities whilst conserving natural resources. In 2006, he co-founded Conversation With Foreigners, a conversational English training institution with a mission to provide conversational English training, create opportunities for foreign volunteers to experience and learn about Cambodia.



DR CHANRITH NGIN Director, Master Program of Development Studies, Royal University of Phnom Penh. Cambodia

Dr Chanrith Ngin is the Dean of the Faculty of Development Studies (FDS) at the Royal University of Phnom Penh (RUPP), Cambodia. He has been a post-doctoral and visiting scholar at various universities in Europe and Asia. His research works comprise economic development, community development, civil society, vocational training, and higher education in Cambodia. Dr Ngin also serves on a number of editorial and advisory boards of national and regional academic outlets and development institutions.



### RAMJI RAGHAVAN Founder and Chairman, Agastya International Foundation, India

Ramji Raghavan is the Founder & Chairman of Agastya International Foundation (www.agastya.org), the world's largest hands-on mobile science education programme for economically disadvantaged children and rural teachers, to support and transform primary and secondary education in India.

Operating with a fleet of 116 Mobile Labs, 47 Science Centers, 59 Lab on Bikes, and a 173-acre campus Creativity Lab near Bengaluru, Agastya has impacted over 6 million economically disadvantaged children and about 200,000 rural school teachers through creative hands-on science education. Agastya's innovative 'TechLaBike Project' was one of four winners of the Google Global Impact Award in 2013.

Raghavan served as a member of the Prime Minister's National Knowledge Commission, Board member of Vigyan Prasar, New Delhi, Karnataka State Innovation Council and Executive Council member of Visvesvaraya Industrial and Technological Museum. In 2009, Raghavan was elected as a Senior Fellow by Ashoka: Innovators for the Public and in 2011 he was conferred the People's Hero Award by the Confederation of Indian Industry (CII).

Raghavan has an MBA from London Business School and a Post-Graduate Diploma in Development Studies from International Institute of Social Studies. Netherlands. He is an alumnus of Delhi University and Rishi Valley School.



## DR ARI S. W POESPODIHARDJO, PhD Lecturer/Researcher, London School of Public Relations (LSPR) - Jakarta, Indonesia

Ari is a lecturer/researcher at the London School of Public Relations (LSPR) in Jakarta. Prior to his academic career, he was a journalist specialising in business news and current affairs.

While working as a journalist for local and international media, Ari had first-hand experience of various issues that took place within and outside of Indonesia. It was during this period that he developed a strong interest for international affairs.

Ari later earned a PhD from Wollongong University (Australia) in 2008. He conducted extensive researches on the correlation between media and the society, particularly after the global economic crisis. These researches also made him one of the finalists for the Australian Alumni Award in 2012.
